# **NTAC National Supported Education Directory**

Welcome to the NTAC National Supported Education Directory!

The purpose of this directory is to gather a listing of supported education programs serving people with serious mental health conditions across the country.

#### What is "supported education"?

Supported education is an approach designed to address the higher education goals of individuals with psychiatric disabilities and/or mental health challenges and support their success in postsecondary settings like community colleges, technical schools, and universities.

Supported education came into existence after another better-known practice, supported employment, which helps people with mental health conditions find and maintain employment. As this SAMHSA blog explains, "While [Supported Employment] demonstrated success in helping people with psychiatric disabilities choose, get, and keep jobs, a 2011 study on the importance of rehabilitation found that many of those jobs were part-time and low-paying, and did not generally lead to real careers that provided enough income for people to become and remain independent" (<a href="www.samhsa.gov/homelessness-programs-resources/hpr-resources/supported-education-programs">www.samhsa.gov/homelessness-programs-resources/hpr-resources/supported-education-programs</a>). To help people attain the sense of purpose and financial stability that comes from a meaningful career, the concept of support designed specifically to enhance success in educational settings came into being. Higher education opens new horizons in terms of career choice and long-term financial stability, so why not build a bridge to higher education through supported education, just as supported employment created a path to the workplace?

Supported education can look different in different contexts, and there are a variety of approaches to helping students with mental health conditions succeed in higher education. Some programs are embedded within specific colleges or universities, while others are free-standing. Some focus on necessary classroom accommodations, some include linkages to care, and some even involve peer support. Whatever a supported education program looks like, the thing they all have in common is the goal of helping students succeed and enjoy the many benefits that accompany getting a degree or post-secondary certification.

As described in the SAMHSA "Supported Education: A Promising Practice" toolkit (<a href="https://store.samhsa.gov/sites/default/files/d7/priv/sma11-4654-buildingyourprogram-sed.pdf">https://store.samhsa.gov/sites/default/files/d7/priv/sma11-4654-buildingyourprogram-sed.pdf</a>), there are a few essential principles that all supported education programs share:

- Access to an education program with **positive**, **forward progress** is the goal.
- Eligibility is based on personal **choice**.
- Supported Education **services begin soon** after someone expresses interest.
- Supported Education is integrated with treatment.
- Individualized educational services are offered for as long as they are needed.
- Consumer preferences guide services.
- Supported Education is **strengths-based** and promotes **growth and hope**.
- Recovery is an ongoing process facilitated by meaningful roles.

While every supported education program is different, most offer these core services:

- Career planning, including vocational assessment, career exploration,
   Educational Goal Plan development, course selection, instruction, support, and counseling.
- Academic survival skills including information about college and training programs, disability rights and resources, tutoring and mentoring services, time and stress management, and social supports.
- **Direct assistance** including help with enrollment, financial aid, education debt, and contingency funds.
- **Outreach** including contact with campus resources, mental health treatment team members, and other agencies such as vocational rehabilitation.

#### How do I find supported education programs?

Ideally, it would be easy for anyone that was interested in pursuing higher education to find a supported education program that could meet their needs. However, despite supported education being a promising evidence-based practice, there is currently no comprehensive listing of supported education programs, and no go-to starting point for individuals or families looking for educational supports.

To fill that gap, the five SAMHSA-funded national consumer and consumer-supporter TA centers came together to create this directory of supported education programs and services for individuals experiencing psychiatric disabilities and/or mental health challenges across the United States and outlying territories. It is a great place to start if you are looking for programs that support the educational success of students with serious mental health conditions.

There are **a few things to keep in mind** when using this directory, and when looking for a supported education program:

 While the programs that came together to create this directory made a concerted effort to identify supported education programs, the directory is not comprehensive. There may be programs out there that are not listed here. If you are aware of any such programs, please let us know so we can add them to the directory! (See details about how to do that below.)

- 2. Many colleges, universities, and programs engage in services that can be similar to supported education without actually using the term "supported **education**" to describe them. It can be helpful to learn more about the services and accommodations available through a given program, and then consider how well they fit a given student's needs, as opposed to searching for a program that uses the term "supported education" specifically. If you are looking at a university, college, or post-secondary training program, ask questions about the availability of accommodations like reduced course loads, extra time to complete assignments, the ability to drop courses if needed, and resources and policies around supporting student mental health. (One resource that can be helpful in that assessment is a publication created by The Bazelon Center entitled Supporting Students: A Model Policy for Colleges and Universities, which breaks down what the ideal campus mental health environment should look like over several categories. It's at www.bazelon.org/Where-We-Stand/Community-Integration/Campus-Mental-Health.aspx). The more you know about what you need and what is available, the more likely you are to find the right fit, whether it's labeled "supported education" or not.
- 3. State Vocational Rehabilitation Agencies can be a great resource. Every state and territory has a "VR" agency that exists solely to help people with all types of disabilities, including those related to mental health conditions, access the supports they need to participate in the workforce. That mandate includes supporting people to obtain the education they need to meet their career goals. #### How do I use the directory?

This directory was created through a combination of a survey and proactive research. Each listing includes a brief description of the program, followed by their responses to our survey questions. If there's no information listed, that means we didn't receive a response to that question. For many listings, the short description will include information that answers at least some of those questions. Each listing includes contact information, and the directory is organized by state.
